Theme: ChildSight

What might we see from a child's perspective?

We leave the interpretation of this theme up to you, the artist. Pieces for the exhibition should relate to the theme, and will be selected based upon a combination of: artistic quality, technical execution and/or conceptual strength, originality and impact.

Our 2013 exhibition will include an interactive, new media layer, presented in collaboration with our ongoing in-school program, Kaleidoscope. Scarborough kids from the Kaleidoscope intercultural arts program will learn how to interpret, discuss and critique artwork, using selected pieces from the exhibition. Audio recordings of these critique sessions will be captured and edited, accompanying the works for public listening in the gallery exhibition.

Conditions of Entry:

- Online submissions are highly preferred. This helps us save much time, space and paper.
- Physical submission packages are acceptable, but will not be returned.
- An entry fee must accompany your submission package
- **Submissions** will only be **validated upon receipt of payment**
- Payment may be made by cheque, cash or credit card in person or via telephone.
- Late entries will not be accepted
- Each artist may submit up to three **(3)** separate pieces of artwork for consideration
- All work must be original and be the creation of the entrant
- SA retains a 30% commission on all work sold during the exhibition
- SA may use images of accepted work for promotional purposes of this exhibition
- Work must be hand-delivered (NOT couriered); SA
- Artists assume all liability for the damage or theft of artwork during transportation
- Artists waive all claims or causes of action against SA and exhibition venue
- Decision of the juror is final
- All entrants will be notified of the juror's decision by SA; no telephone inquiries please
- Works must be wired and ready for hanging and sale at time of drop-off
- Delivery, shipment and return shipment arrangements are the responsibility of the artist
- **Accepted work must be delivered to Papermill Gallery (67 Pottery Road, Toronto, ON) on Monday, March 11, 2013 between 12:30pm & 4:30 pm**
- **Accepted work must be retrieved from Papermill Gallery (67 Pottery Road, Toronto, ON) on Monday, March 25, 2013 between 9:30am & 12:00 pm**
